

**OFFICIAL PROCEEDINGS OF THE RICH TOWNSHIP BOARD OF TRUSTEES**

**Call to Order:** Supervisor Al Riley called the meeting to order at 5:35 p.m. and led the Pledge of Allegiance.

**Approval of Bills:** Upon a motion made by Trustee Goodrich, seconded by Trustee Bobis, and unanimously passed by roll call vote, the Board approved Town Fund checks #30092--30272 in the amount of \$356,283.13; General Assistance Fund checks #21897--22056 in the amount of \$38,629.70; Road District Fund checks #6039--6067 in the amount of \$19,902.47; Donations Fund checks #1583--1585 in the amount \$1,369.89; and Senior Companion Fund checks #9710--9767 in the amount of \$24,017.13 for the period of 04/28/15 thru 05/26/15.

**Approval Of Minutes:** Upon a motion made by Trustee Bobis, seconded by Trustee Small, and unanimously passed by voice vote, the Board approved the minutes of the May 4, 2015 Board of Trustees meeting as presented.

**Approval of Executive Session Minutes:** Upon a motion made by Trustee Goodrich, seconded by Trustee Bobis, and unanimously passed by voice vote, the Board approved the minutes of the May 4, 2015 Executive Session meeting as presented.

## PUBLIC PETITIONS

All of the above named residents of Polk Avenue in Unincorporated Matteson expressed concerns regarding the road extension at the end of Polk Avenue, and the township's lack of knowledge that it had been extended. Other concerns noted were lack of notification to the residents of Polk Avenue, additional traffic issues, quiet and safety concerns, and nature and appearance of the area. George and Barbara Gomall added that they were having difficulty getting in and out of their own driveway.

Supervisor Al Riley suggested that a meeting be arranged with Village of Richton Park's Village President and public works director, U.S. Congresswoman Robin Kelly's office, Cook County Commissioners Deborah Sims and Joan Murphy, Highway Commissioner Calvin Jordan and himself to address the residents' questions and concerns.

**Clerk:** Clerk Bobbie King reported that unincorporated Cook County vehicle stickers are available, and that the due date for display is July 1<sup>st</sup>. She thanked Trustees Nick Bobis, Therese Goodrich, Jackie Small and Highway Commissioner Calvin Jordan for presenting the Good Citizenship Scholarship Awards. Clerk King noted that TOCC was encouraging townships to share information and milkweed seeds with residents in an effort to save the monarch butterfly. She attended the Pantry Volunteer Luncheon.

**Highway Commissioner:** Commissioner Calvin Jordan reported that he had approved and signed Ordinance 15-07-Adopting the Prevailing Wage Act. He noted that his staff would be planting flowers as part of a beautification project, and that he presented the Good Citizenship Scholarship Award at Homewood-Flossmoor High School.

**Trustee Goodrich:** Attended the Pantry Volunteer Luncheon, the Township's Senior Fair, the Annual League of Women Voters meeting, the Governors State University Gala Fundraiser for Performing Arts, and presented the Good Citizenship Scholarship Award at Rich East High School.

**Trustee Johnson:** Attended the Pantry Volunteer Luncheon, School District 159's graduation, and was guest speaker at the Cook County Assessor's Association meeting. Trustee Elliott Johnson reported that he was humbled by his election as President of the TOCC Board.
