Call to Order: Supervisor Al Riley called the meeting to order at 5:33 p.m. and led the Pledge of Allegiance.

PUBLIC HEARING

Supervisor Al Riley announced that this Public Hearing was being held to present Rich Township's 2014-2015 Town Fund and Road & Bridge Budgets and Appropriations. Supervisor Riley and Finance Manager Carney Barr answered questions regarding the proposed Budget and Appropriations Ordinances 14-05 and 14-06; he then closed the hearing, and reconvened the Board Meeting.

Town Fund, General Assistance Fund, Road District Fund, Donation Fund and Senior Companion Fund: Upon a motion made by Trustee Goodrich, seconded by Trustee Small, and unanimously passed by roll call vote, the Board approved Town Fund checks #27335--27586 in the amount of \$321,384.90; General Assistance Fund checks #19684--19872 in the amount of \$35,965.92; Road District Fund checks #5613—5639 in the amount of \$18,991.60; Donations Fund checks #1538--1540 in the amount \$12,364.64; and Senior Companion Fund checks #8889--8955 in the amount of \$24,700.57 for the period of 03/28/14 thru 04/30/14.

Approval Of Minutes: Upon a motion made by Trustee Bobis, seconded by Trustee Johnson, and unanimously passed by voice vote, the Board approved the minutes of the April 2, 2014 Board of Trustees meeting as presented.

PUBLIC PETITIONS

Everett James of Unincorporated Matteson stated that he was looking for legal assistance for someone who bought a house from a bank. He added that the person did not have a home inspection, and that the plumbing is in such disrepair that he has been forced to leave the home. Supervisor Riley gave some suggestions including Illinois Attorney General Lisa Madigan's office, adding that a home inspection is highly recommended when purchasing a home.
