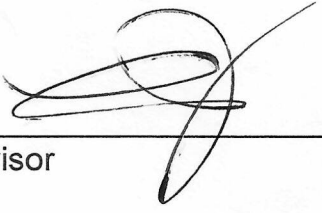
**Trustee Burris:** Absent.

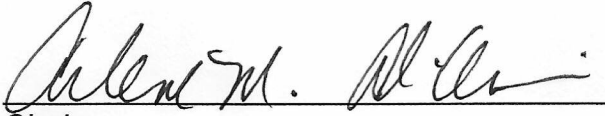
