

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 20-10

An ordinance levying taxes for all town purposes for Rich Township, Cook County, Illinois, for the tax year 2020 collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Rich Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of Three Million, Nine Hundred Thirty Nine Thousand, Three Hundred Fifty and 00/100 Dollars (\$ 3,939,350.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

and General Assistance Fund.

for the year 2020.
