TAX LEVY ORDINANCE

ORDINANCE NO. 24-13

An ordinance levying taxes for all road purposes for Rich Township Road District, Cook County, Illinois, for the tax year 2024 collectible in 2025.

BE IT ORDAINED by the Board of Trustees of Rich Township, Cook County, Illinois, as follows:

SECTION 1: That the Board of Trustees of Rich Township

on December 03, 2024 does hereby determine and declare that the sum of One Million,

Three Hundred Eighty-Three Thousand, Two Hundred Sixty-Two and 00/100 (1,383,262.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund, for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
