Call to Order: Supervisor Calvin Jordan called the meeting to order at 5:32 p.m. and led the Pledge of Allegiance.

Approval of Bills: Upon a motion made by Trustee Small, seconded by Trustee Burris, and unanimously passed by roll call vote, the Board approved Town Fund checks #43750-43810 in the amount of \$164,690.52; General Assistance Fund checks #31857--31889 in the amount of \$30,112.12; Road District Fund checks #9347--9357 in the amount of \$26,945.23 for the periods of 10/16/24 through 10/29/24.
