An ordinance levying taxes for all road purposes for Rich Township Road District, Cook County, Illinois, for the tax year 2021 collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Rich Township, Cook County, Illinois, as follows:

SECTION 1: That the Board of Trustees of Rich Township
on December 6, 2021 does hereby determine and declare that the sum of One Million,
Three Hundred Thirty Thousand, and 00/100 (1,330,000.00) is hereby
levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the
Road District as required by statute or voted by the people in accordance with the law,
for such purposes as:

for the year 2021.
