NEW BUSINESS

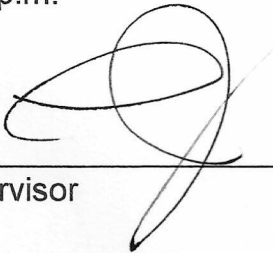

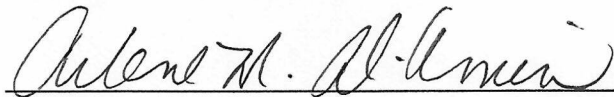
Administrator Trinette Britt along with Finance Director Alana Thompson, gave an update to the Board on grant funding/spending.
