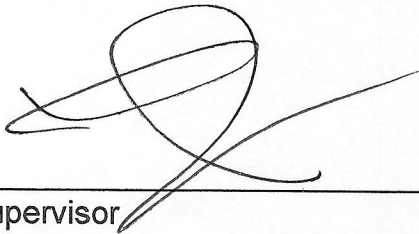

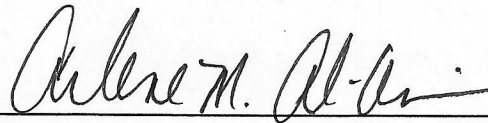
Attorney: No Report
