On June 26, 2020, Governor Pritzker issued the fifth Gubernatorial Disaster Proclamation for all counties in the State of Illinois. Due to the COVID-19 health pandemic, Calvin Jordan, Township Supervisor, has determined that an in-person meeting is not practical or prudent. As permitted by Public Act 101-0640, this meeting will be held without the physical presence of a quorum at the meeting location.

During the meeting, the Township Supervisor will be physically present at 22013 Governors Highway, Richton Park, IL 60471. In-person attendance at that location by members of the public will be limited in order to comply with social-distancing guidelines. Face coverings are required for any public attendees.
